What we do with your personal data

We use the personal data you give to us to process your application. We will be sharing the data you provide with the Financial Conduct Authority.

In order to process this application, your information may be shared with, and used by, a number of third parties in the regulatory, insurance and risk sector; for example, sanction checking sub-contractors, credit reference agencies, regulators, law enforcement agencies, fraud and crime prevention and detection agencies and compulsory insurance databases. We will only disclose your personal information in connection with the application and to the extent required or permitted by law.

What personal data do we collect?

We collect and use relevant information to process your application and to meet our legal obligations.

This information includes company details but will also include personal data of individuals such as name, address, data of birth and contact details.

Special categories of personal data such as criminal convictions may be collected and processed on a consent or public interest basis if this is necessary for insurance purposes.

Your data will be held securely in the UK and the EEA. Any other data processing outside of these geographical areas will be undertaken only in locations that are covered by UK data protection adequacy regulations or where UK GDPR compliant appropriate safeguards are in place.

How do we look after personal data?
